What puts New Hanover County at a higher risk for underage alcohol use?

- Availability
 - Parents/Adults providing alcohol for proms & graduation celebrations
 - Off-premise outlets that sell alcohol to underage purchasers
 - Community events with alcohol
- Parent/Adult Tolerance
 - Greater acceptance than other drugs

What puts New Hanover County at a higher risk for youth prescription drug abuse?

- Perceived as less harmful than "other drugs"
- Parents/adults are unaware of prescription misuse as a problem
- Prescription drugs are legal
- It's okay to use prescription medications if they are prescribed by a doctor

How Does Underage Drinking Affect Our Community

How Does Underage Alcohol Use Affect Our Community?

- In the 2007 Youth Risk Behavior Survey:
 - 47% of New Hanover County youth reported drinking alcohol in the past 30 days
 - 30% had five or more drinks in a row (i.e. binge drinking) in the past 30 days
 - 28% rode in a car or other vehicle with someone who had been drinking alcohol in the past 30 days

How Does Underage Drinking Affect Our Community?

- Youth who drink before the age of 15 are 4 times more likely to develop alcohol dependency than those who wait until the age of 21 or older.
- Underage drinking cost the citizens of North Carolina \$1.4 billion in 2007.
- During 2007, an estimated 65 traffic fatalities and 2,700 nonfatal traffic injuries involved an underage drinking driver.

Did You Know?

- Approximately 351,000 underage youth in North Carolina drink each year
- In 2007, underage drinkers consumed 10.4% of all alcohol sold in North Carolina
- In the United States alone, alcohol kills more kids than all illegal drugs combined.

Attitudes & Perceptions of Harm/ Risk Regarding Marijuana Use

- Marijuana use is perceived as the "norm"
- The most-cited risk associated with marijuana use are those related to getting caught, getting arrested and going to jail
- Marijuana use is reported as presenting low or no risk of harm by focus groups
- College-age participants identified job or employment concerns and employment-related dug screens as the primary fear they and their peers share with respect to marijuana use.
 - They also said that when marijuana is made legal, those fears/threats to employment will go away
- Among the benefits of marijuana use mentioned by focus group participants of all ages was its relaxing effects and its positive effects as a means of stress relief
